- C. RENDER LESSOR HARMLESS IF MECHANICAL FAILURE TO OUR EQUIPMENT PREVENTS DELIVERY.
- D. PAY ANY AND ALL REASONABLE ATTORNEY FEES, COURT COSTS, WITNESS FEES, COURT REPORTER, SERVICE FEES AND ANY AND ALL OTHER EXPENSES REQUIRED BY THE LESSOR TO ENFORCE THIS LEASE AGREEMENT OR FOR THE COLLECTION OF MONEY OWED AND DUE TO THE LESSOR.
- E. TO PROVIDE RISK OF LOSS INSURANCE AND LIABILITY INSURANCE ON ALL ITEMS AND EQUIPMENT LEASED AND WILL BE RESPONSIBLE FOR ALL DAMAGES, RISK OF LOSS, THEFT, FIRE OR ANY OTHER DAMAGES WHETHER SEEN OR UNFORSEEN TO EQUIPMENT ONCE DELIVERED TO LESSEE AND UNTIL DELIVERY BACK TO LESSOR'S PLACE OF BUSINESS.
- F. NOT ALLOW ANY PERSON WITHOUT A VALID DRIVERS LICENSE TO OPERATE ANY OF THE RENTED GOLF CARS.
- G. THE CONSTRUCTION AND PERFORMANCE OF THIS LEASE AGREEMENT SHALL BE DEEMED TO BE GOVERNED BY THE LAWS OF THE STATE OF ILLINOIS. BY EXECUTING THIS LEASE AGREEMENT, LESSEE AGREES VENUE AND THE IN PERSONAM JURISDICTION WHICH IS CHOSEN BY THE LESSOR. LESSEE FURTHER WAIVES ITS RIGHT, IF ANY, TO REMOVE AN ACTION FILED BY LESSEE TO FEDERAL COURT OR TO A DIFFERENT VENUE IN ILLINOIS THAN THAT FILED BY THE LESSOR.
